

# Condition of Entry

## Social Impact Institute strive to run COVIDSafe events but need your help!

All Staff/Exhibitors/Attendees of the Expo will be required to register for the event before being granted access to the venue. Entry is free and visitors are encouraged to pre-register online prior to coming to the venue. A unique QR code will be generated once registration has been complete. Entry is granted subject to completing registration and a COVIDSafe Screening Questionnaire prior to entry.

All registration records will be securely stored as a result of COVID-19 contact tracing requirements of Queensland Health. Any persons attempting to enter the venue without first registering and completing the COVIDSafe Screening Questionnaire will be asked to move away from the venue entrance and either join the registration queue or register via a personal mobile device.

### **CovidSafe:**

All Staff/Exhibitors/Attendees will also be required to complete a separate COVIDSafe Screening Questionnaire. This is aimed to ensure that every person entering the venue are not suffering COVID-19 symptoms, have not come in contact with a casual or close contact and therefore reducing the risk of passing on the virus. Records will be stored as a result of COVID-19 contact tracing requirements of Queensland Health. Below is a brief summation of what type of information the COVIDSafe Questionnaire will be requiring:

If, in the past fourteen (14) days:

- You have been overseas;
- You have been in contact with a person with a confirmed case of COVID-19;
- You have been in a COVID-19 hotspot;
- You have had COVID-19;
- You have had symptoms consistent with COVID-19,

You will be unable to enter the Expo.

If you have symptoms conducive with COVID-19 (e.g. fever, cough, shortness of breath, sore throat or headache), you must not enter the Expo.

### **Additionally:**

- Social distancing measures of 1.5 metres between people/household groups must be maintained at all times.
- Hand sanitisation stations and hand washing stations will be available throughout the event and will be easily identifiable by signage. Patrons are encouraged to ensure that they regularly wash and/or sanitise their hands during their visit to the Expo.
- One-way aisle directional flow will be in place together with a single entry and exit point.
- Regular Expo announcements will be conducted over the PA system to remind all attendees at the event to ensure hygiene considerations are observed and one way aisle traffic flows are maintained
- Social Distancing Volunteer Staff will be positioned throughout the venue specifically to monitor and encourage social distancing in all walkways, ensure one person/household groups are at exhibitor booths at any one time and social distances are adhered to in high traffic areas.
- In the event that people find themselves in a queued situation at the entry point to the event venue, we ask that you practice physical distancing in your household groups of no less than 1.5 metres. Social distance markers will be in place to assist with keeping the correct 1.5 metres apart.
